PUBLIC HEARING

1. Commission discussion and consideration of **Resolution No. PC 24-06**, forwarding a recommendation to the City Council to approve an exemption under the California Environmental Quality Act and approve Rezone 24-01 (Assessor's Parcel Number 013-105-18).

Chairperson Escobedo introduced the item and Assistant City Planner Czeshinski provided the report.

Discussion was held on the report provided by Assistant City Planner Czeshinski.

Chairperson Escobedo opened the public hearing and seeing no one willing to comment closed it within the same minute.

A motion was made by Commissioner Gutierrez to adopt Resolution No. PC 24-06, seconded by Commissioner Garcia; unanimously approved (4 ayes, absent: Perez).

2. Commission discussion and consideration of **Resolution No. PC 24-07**, forwarding a recommendation to the City Council to approve an exemption under the California Environmental Quality Act and approve Rezone 24-02 (Assessor's Parcel Number 013-105-19).

Chairperson Escobedo introduced the item and Assistant City Planner Czeshinski provided the report.

Chairperson Escobedo opened the public hearing and seeing no one willing to comment closed it within the same minute.

A motion was made by Commissioner Sanchez to adopt Resolution No. PC 24-07, seconded by Commissioner Garcia, unanimously approved (4 ayes, absent: Perez).

3. Commission discussion and consideration of **Resolution No. PC 24-08**, recommending that the City Council amend Mendota Municipal Code section 17.24.080 and finds that such activities are exempt from further environmental analysis pursuant to California Environmental Quality Act Guidelines section 15061(b)(3).

Chairperson Escobedo introduced the item and Assistant City Planner Czeshinski provided the report.

Discussion was held on the report provided by Assistant City Planner Czeshinski; on the need for housing in the City; and the need for mobile trailer homes to meet all building requirements in order to be permitted.

Chairperson Escobedo opened the public hearing at 6:45 p.m.

Benjamin Escobar commented on a building permit he submitted to install a mobile trailer home, including the permit not being approved due to the mobile trailer home being 20 days older than what is permitted under the Mendota Municipal Code ("MMC"); inquired into whether the City may possibly allow him to install the mobile trailer home due to it only being older by 20 days of what is permitted under the MMC and commented on his willingness to go through the building permit process.

Discussion was held on the comments made by Mr. Escobar; the City's building permit requirements; and the need for the City Council to approve the proposed amendment to MMC section 17.24.080 in order for the mobile trailer home to be permitted.

Chairperson Escobedo closed the public hearing at 6:52 p.m.

A motion was made by Commissioner Gutierrez to adopt Resolution No. PC 24-08, seconded by Commissioner Sanchez; unanimously approved (4 ayes, absent: Perez).
