Proclamation No. 24-01

Recognizing the Mendota Unified School District Expanded Learning Program and Proclaiming November 7, 2024 as "Lights On Afterschool Day"

WHEREAS, the citizens of the City of Mendota stand firmly committed to quality afterschool programs and opportunities because they:

- Provide safe and engaging learning experiences that help children realize their full potential and support their academic growth and well-being.
- Support working families by ensuring their children are safe and productive when they are out of their classrooms.
- Help address key issues in our state such as school absenteeism, learning loss recovery, and workforce development.
- Build stronger communities by involving students, parents, businesses, and volunteers in the lives of young people.
- Provide a solid return on investment. Every \$1 invested in afterschool programs saves at least \$3 by increasing kids' earning potential; improving kids' performance at school; and reducing crime and juvenile delinquency.

WHEREAS, afterschool programs provide critical support for children and youth, offering them new experiences and opportunities, along with hands-on learning, that help them learn and grow. Youth who attend afterschool programs attend school more often, do better in school, and gain important work and life skills. These supports are all the more important today; and

WHEREAS, the Mendota Unified School District Aztec Expanded Learning Program is committed to the education and well-being of our youth, and recognizes that quality afterschool programs prepare our children to become successful adults, and help our community thrive; and

WHEREAS, Lights On Afterschool, the national celebration of afterschool programs held this year on October 24, 2024, promotes the importance of quality afterschool programs for our children, families, and communities; and

WHEREAS, the demand for afterschool programs continues to grow; for every child in a program, four are waiting to get in; and

WHEREAS, many afterschool programs face operating challenges so severe that they are forced to consider closing their doors and turning off their lights; and

WHEREAS, the State of California is committed to providing expanded learning opportunities that help our children learn, grow, and develop the skills essential for success in life and work.

NOW, THEREFORE BE IT RESOLVED, that the City Council of the City of Mendota recognizes the Mendota Unified School District Expanded Learning Program and does hereby proclaim November 7, 2024, as "Lights On Afterschool Day" in the City of Mendota.

BE IT FURTHER RESOLVED, that the City Council of the City of Mendota endorses *Lights On Afterschool* and commits our city to engage in innovative afterschool programs and activities that ensure the lights stay on and the doors stay open for all children after school.

SUBJECT: DECLARING SURPLUS CERTAIN CITY-OWNED PERSONAL PROPERTY AND AUTHORIZING THE SALE OR DISPOSAL OF SUCH PROPERTY

DATE: SEPTEMBER 17, 2024

ISSUE

Shall the City Council adopt Resolution No. 24-51, declaring surplus certain City-owned personal property and authorizing the sale or disposal of such property?

BACKGROUND

Mendota Municipal Code ("MMC") Chapter 3.20 allows the sale of any and all City of Mendota ("City") personal property which has been deemed excess or unnecessary for City operation, and also provides for the destruction of certain property. MMC 3.20 outlines the requirements for the sale and destruction of City surplus property.

ANALYSIS

Attached to Resolution No. 24-51 are two lists that describe City property that has been deemed excess or unnecessary for City operation. One list, attached to Resolution No. 24-51 as Exhibit "A," includes property to be sold. These items have been valued based on available source material and will be sold in a "garage sale" type of set up as described below. The second list, attached to Resolution No. 24-51 as Exhibit "B," includes property to be destroyed due to the items being ineligible as described in MMC Section 3.20.030, including that the items are damaged and pose a potential risk and they present general liabilities to the City.

Following the City Council's approval of Resolution No. 24-51 and its exhibits, the City Clerk will publish a public notice in the Firebaugh-Mendota Journal and in three (3) local public places. The public notice will list property with a valuation of \$100.00 or greater (which will be sold via sealed bids that will be accepted until Wednesday, October 23rd by 5pm) and that the public may view the items by appointment. Property valued at less than \$100.00 will be sold on Wednesday, October 23rd from 12pm-4pm at the Public Works Yard located at 912 Marie Street, in a "garage sale" type of set up with the valuation amount placed upon or near the item.

At the November 5th regular City Council meeting, the City Council will then authorize the sale of items with a valuation of \$100.00 or more to the highest bidder. The City Council will also authorize the final disposition of items that are not sold either through the garage sale or sealed bids. These items will then be eligible to be scrapped, discarded, or sold directly by the City Manager to any interested persons.

FISCAL IMPACT

Minor revenue for the General Fund from the sale of property to interested persons.

RECOMMENDATION

Staff recommends that the City Council adopt Resolution No. 24-51, declaring surplus certain City-owned personal property and authorizing the sale or disposal of such property.

RESOLUTION NO. 24-51

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENDOTA DECLARING SURPLUS CERTAIN CITY-OWNED PERSONAL PROPERTY AND AUTHORIZING THE SALE OR DISPOSAL OF SUCH PROPERTY

WHEREAS, Government Code section 37350 allows cities to dispose of property for the common benefit; and

WHEREAS, the City of Mendota ("City") has personal property that is deemed excess, surplus, and unnecessary for the City's operations; and

WHEREAS, Mendota Municipal Code ("MMC") Chapter 3.20 outlines the process authorizing the sale and disposition of City-owned personal property; and

WHEREAS, the personal property identified to be sold is listed in the documents attached hereto as Exhibit "A," and the property identified to be destroyed is listed in the document attached hereto as Exhibit "B"; and

WHEREAS, the sale and disposal of this surplus personal property is necessary to maintain organization and preserve storage space within City facilities.

ISSUE

Shall the City Council adopt Resolution No. 24-52, approving the Consultant Services Agreement and Proposal from Provost & Pritchard Consulting Group for Land Surveying and Engineering Services for the 2024 Local Streets Improvement Project?

BACKGROUND

On a letter dated August 27, 2024, the City of Mendota ("City") was notified that in the Consolidated Appropriations Act, 2024 and the Further Consolidated Appropriations Act, 2024 Congress made funding available for Community Project Funding ("CPF"). These CPF awards are administered by the Department of Housing and Urban Development ("HUD") and the City was awarded \$5,000,000.00 (Grant No. B-24-CP-CA-0173, as requested by Congressman John Duarte, for the "Mendota Pavement Management Project". We will refer to this project as the "2024 Local Streets Reconstruction Project" to not confuse it with any past or future pavement management projects.

At the April 4, 2024 regular City Council meeting, the Council directed staff to focus the street improvements on the following street segments:

- 1. <u>Tule Street Seventh Street to Ninth Street</u>
- 2. <u>Riofrio Street Fourth Street to Fifth Street</u>
- 3. <u>Riofrio Street Sixth Street to Seventh Street</u>
- 4. <u>Quince Street Tenth Street to Belmont Avenue</u>
- 5. Lolita Street Divisadero Street to Tenth Street
- 6. Jennings Street Ninth Street to Quince Street
- 7. <u>Fourth Street Riofrio Street to State Route 180 (Oller Street)</u>
- 8. Fourth Street –H Street to L Street
- 9. Kate Street I Street to the northern terminus
- 10. <u>I Street Kate Street to Divisadero Street</u>

ANALYSIS

The streets identified are all classified as "local" streets, which are a large part of the overall City street network.

Public Works Department staff has identified no sewer main or sewer lateral issues with the identified street sections, however, they are aware of some water main or service lateral issues that need to be addressed before the streets are repaved in order to protect the substantial investment in the new pavement. They are as follows:

- 1. <u>Tule Street Seventh Street to Ninth Street:</u> Replacement of water main and service lines
- 2. <u>Riofrio Street Fourth Street to Fifth Street:</u> No issues
- 3. <u>Riofrio Street Sixth Street to Seventh Street:</u> Replacement of water service lines
- 4. <u>Quince Street Tenth Street to Belmont Avenue</u>: Replacement of water main and service lines
- 5. <u>Lolita Street Divisadero Street to Tenth Street:</u> Replacement of water service lines
- 6. Jennings Street Ninth Street to Quince Street: No issues
- 7. Fourth Street Riofrio Street to State Route 180 (Oller Street): No issues
- 8. <u>Fourth Street –H Street to L Street:</u> Replacement of water service lines
- 9. <u>Kate Street I Street to the northern terminus:</u> No issues
- 10. <u>I Street Kate Street to Divisadero Street:</u> Replacement of water main

In addition to the asphalt roadway pavement, limited concrete improvements will also be made to improve/provide curb ramps, repair failed curbs, driveways and/or alley approaches, and repair hazardous sidewalk conditions.

FISCAL IMPACT

The City Engineer has performed initial rough order of magnitude construction cost estimates for this project.

The \$5,000,000.00 in CPF funds are eligible for use on streets classified as "local", which is beneficial to the City because other sources of Federal funds are limited to "collectors" and "arterials" and these funds will be utilized for the street improvements of the construction contract.

Approximately \$750,000.00 of water main and service improvements will be paid for from the Water & Sewer Enterprise Fund.

Approximately \$750,000.00 in Local Street funds will be utilized for preconstruction and construction management and administration services.

There will be no impact to the General Fund from this project.

RECOMMENDATION

Staff recommends that the City Council adopt Resolution No. 24-52, approving the Consultant Services Agreement and Proposal from Provost & Pritchard Consulting Group for Land Surveying and Engineering Services for the 2024 Local Streets Improvement Project.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MENDOTA APPROVING THE CONSULTANT SERVICES AGREEMENT AND PROPOSAL FROM PROVOST & PRITCHARD CONSULTING GROUP FOR LAND SURVEYING AND ENGINEERING SERVICES FOR THE 2024 LOCAL STREETS IMPROVEMENT PROJECT

WHEREAS, the City of Mendota ("City") has been awarded \$5,000,000 in Community Project Funding ("CPF") funds, appropriated by Congressman John Duarte, for the construction of the "Mendota Pavement Management Project" to be referred to as the "2024 Local Streets Improvement Project"; and

WHEREAS, the CPF program is administered by the Department of Housing and Urban Development ("HUD") and is also coordinated through the California Department of Transportation ("Caltrans") and Fresno Council of Governments ("FCOG"); and

WHEREAS, in April 4, 2024, the City Council identified the following ten local street segments to be included in the project 1) Tule Street: Seventh Street to Ninth Street; 2) Riofrio Street: Fourth Street to Fifth Street; 3) Riofrio Street: Sixth Street to Seventh Street; 4) Quince Street: Tenth Street to Belmont Avenue; 5) Lolita Street: Divisadero Street to Tenth Street; 6) Jennings Street: Ninth Street to Quince Street; 7) Fourth Street: Riofrio Street to Oller Street; 8) Fourth Street: H Street to L Street; 9) Kate Street: I Street to northern terminus; and 10) I Street: Kate Street to Divisadero Street; and

WHEREAS, the City's Public Works Department staff has identified no sewer main or sewer lateral issues within these street segments; and

WHEREAS, the City's Public Works Department staff has identified issues with water mains and/or services on six of the ten street segments that will be addressed prior to repaying the streets; and

WHEREAS, construction of the project is programmed in the Federal Transportation Improvement Program ("FTIP") for Federal Fiscal Year 2024/2025; and

WHEREAS, the City intends to retain the City Engineer, Provost & Pritchard Engineering Group, Inc. dba Provost & Pritchard Consulting Group, to provide land surveying and engineering services necessary to prepare construction ready bid documents and submit Request for Authorization documents to Caltrans and HUD for the Federal CPF funds for construction; and

WHEREAS, the City Engineer has submitted a proposal that is acceptable to City staff.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Mendota that the Consultant Services Agreement and Proposal submitted by Provost & Pritchard Consulting Group are hereby approved in substantially the forms attached hereto as Exhibit "A" and "B," respectively, and that the City Manager, or his designee, is hereby authorized to execute all documents required to effect each agreement and to execute all documents necessary to complete the Request of Authorization for construction funding for the "2024 Local Streets Improvement Project" (aka "Mendota Pavement Management Project") to HUD and Caltrans.

Description of Services:

As outlined in proposal dated September 10, 2024.

The provisions set forth below and on the following paragraphs 1 through 42 are incorporated into and made a part of this Agreement. In signing, the Client acknowledges that they have read and approved all such terms and hires Provost & Pritchard Engineering Group, Inc., dba Provost & Pritchard Consulting Group, (Consultant) to perform the above described services.

TERMS AND CONDITIONS

Client and Consultant agree that the following terms and conditions shall be part of this agreement:

- 1. In providing services under this Agreement, the Consultant shall perform in a manner consistent with that degree of care and skill ordinarily exercised by members of the same profession currently practicing under similar circumstances at the same time and in the same or similar locality. The Consultant makes no warranty, express or implied, as to its professional services rendered under this Agreement.
- 2. Client acknowledges that Consultant is not responsible for the performance of work by third parties including, but not limited to, the construction contractor and its subcontractors.
- 3. Client agrees that if Client requests services not specified in the scope of services described in this agreement, Client will pay for all such additional services as extra services, in accordance with Consultant's billing rates utilized for this contract.

DOCUMENTS

4. Client acknowledges that all reports, plans, specifications, field data and notes and other documents, including all documents on electronic media, prepared by Consultant (collectively Work Product) are instruments of service which shall remain the property of Consultant and may be used by Consultant without the consent of Client. Consultant shall retain all common law, statutory law and other rights, including copyrights. Consultant grants Client a perpetual, royalty-free fully paid-up, nonexclusive and irrevocable license to copy, reproduce perform, dispose of, use and re-use the Work Product in connection with the Project, in whole or in part, and to authorize others to do so for the benefit of Client. Client acknowledges that its right to utilize Work Product pursuant to this agreement will continue only so long as Client is not in default, pursuant to the terms and conditions of this agreement, and Client has performed all its obligations under this agreement.

- 5. Client agrees not to reuse Work Product, in whole or in part, for any project other than the project that is the subject of this agreement. Client further agrees to waive all claims against Consultant resulting in any way from any unauthorized changes or unauthorized reuse of the Work Product for any other project by anyone on Client's behalf. Client agrees not to use or permit any other person to use versions of Work Product which are not final and which are not signed and stamped or sealed by Consultant. Client shall be responsible for any such use of non-final Work Product. Client hereby waives any claim for liability against Consultant for use of non-final Work Product. If a reviewing agency requires that check prints be submitted with a stamp or seal, those shall not be considered final for purposes of this paragraph.
- 6. In the event Client (1) makes, agrees to, authorizes, or permits changes in Work Product, or (2) makes, agrees to, authorizes, or permits construction of such unauthorized changes, which changes are not consented to in writing by Consultant, or (3) does not follow recommendations prepared by Consultant pursuant to this agreement, resulting in unauthorized changes to the project, Client acknowledges that the unauthorized changes and their effects are not the responsibility of Consultant. Client agrees to release Consultant from all liability arising from such unauthorized changes, and further agrees to defend, indemnify and hold harmless Consultant, its officers, directors, employees and subconsultants from and against all claims, demands, damages or costs, including attorneys' fees, arising from such changes.
- 7. Under no circumstances shall delivery of Work Product for use by the Client be deemed a sale by the Consultant, and the Consultant makes no warranties, either express or implied, of merchantability and fitness for any particular purpose. In no event shall the Consultant be liable for indirect or consequential damages as a result of the Client's unauthorized use or reuse of the Work Product.
- 8. The Client is aware that differences may exist between electronic files delivered and the printed hardcopy construction documents. In the event of a conflict between the signed construction documents prepared by the Consultant and electronic files, the signed sealed hard-copy documents shall govern.

LIMITATIONS

- 9. Consultant makes no representations concerning soils or geological conditions unless specifically included in writing in this agreement, or by amendments to this agreement. If Consultant recommends that Client retain the services of a Geotechnical Engineer and Client chooses to not do so, Consultant shall not be responsible for any liability that may arise out of the making of or failure to make soils or geological surveys, subsurface soils or geological tests, or general soils or geological testing.
- 10. Client acknowledges that, unless specifically stated to the contrary in the proposal's description of services to be provided, Consultant's scope of services for this project does not include any services related in any way to asbestos and/or hazardous or toxic materials. Should Consultant or any other party encounter such materials on the job site, or should it in any other way become known that such materials are present or may be present on the job site or any adjacent or nearby areas which may affect Consultant's services, Consultant may, at its option, suspend or terminate work on the project until such time as Client retains a qualified contractor to abate and/or remove the asbestos and/or hazardous or toxic materials and warrant that the job site is free from any hazard which may result from the existence of such materials.

INDEMNIFICATION

11. To the fullest extent allowed by law, Consultant will indemnify and hold harmless, but shall have no duty to defend Client, its officers. directors, employees and agents (collectively, the "Client Indemnitees") from, for and against any and all claims, demands, damages, losses. expenses. liabilities and penalties arising out of or relating to the Project, but only to the extent caused by the negligent or other wrongful acts or omissions of Consultant, its subconsultants, or any person or entity for whose acts or omissions any of them are responsible, or by the failure of any such party to perform as required by this Agreement. To the fullest extent allowed by law, Client will indemnify and hold harmless, but shall have no duty to defend Consultant and its officers, directors, employees and agents from, for and against any and all claims, demands, damages, losses, expenses, liabilities and penalties arising out of or relating to the extent caused by the negligent or other wrongful acts or omissions of Consultant and its officers, directors, employees and agents from, for and against any and all claims, demands, damages, losses, expenses, liabilities and penalties arising out of or relating to the Project, but only to the extent caused by the negligent or other wrongful acts or omissions of Client or any person or entity for whose acts or omissions it is responsible, or by the failure of any such party to perform as required by this Agreement. The obligations and rights of this Section are in addition to other obligations and rights of indemnity provided under this Agreement or applicable law.

FINANCIAL

- 12. All fees and other charges due Consultant will be billed monthly and shall be due at the time of billing unless specified otherwise in this agreement. If Client fails to pay Consultant within sixty (60) days after invoices are rendered, Consultant shall have the right in its sole discretion to consider such default in payment a material breach of this entire agreement, and, upon written notice, Consultant's duties, obligations and responsibilities under this agreement may be suspended or terminated for cause pursuant to Sections 26 through 31. In such event, Client shall promptly pay Consultant for all outstanding fees and charges due Consultant at the time of suspension or termination including all costs and expenses incurred in the performance of services up to suspension or termination.
- 13. Consultant shall not be liable to Client for any costs or damages that may result from the termination or suspension of services under this agreement due to Client's failure to pay Consultant invoices in accordance with the terms of this paragraph. In the event that Consultant agrees to resume terminated or suspended services after receiving full payment of all late invoices, Client agrees that time schedules and fees, as applicable, related to the services will be equitably adjusted to reflect any delays or additional costs caused by the termination or suspension of services.
- 14. In all cases where the proposal calls for payment of a retainer, that payment shall be made by Client to Consultant prior to commencement of services under this agreement. Upon receipt of retainer payment, the Consultant shall commence services as provided for under this Agreement. Unless otherwise provided for in the project proposal, such retainer shall be held by Consultant throughout the duration of the contract, and shall be applied to the final project invoice, and to any other outstanding AR, including late payment charges, on the project. Any amount of said retainer in excess of the final invoice and other outstanding AR shall be returned to the Client within 30 days of issuance of the final project invoice.
- 15. Client agrees that all billings from Consultant to Client will be considered correct and binding on Client unless Client, within ten (10) days from the date of receipt of such billing, notifies Consultant in writing of alleged inaccuracies, discrepancies, or errors in billing. In the event of a dispute over any billing or portion of billing, Client agrees to pay the undisputed portion of any billings in accordance with the payment terms set forth in Section 18.
- 16. Client agrees to pay a monthly late payment charge, which will be the lesser of one and one half percent (1-1/2%) per month or a monthly charge not to exceed the maximum legal rate, which will be applied to any unpaid balance commencing thirty (30) days after the date of the billing. Client acknowledges that payments applied first to unpaid late payment charges and then to unpaid balances of invoices.
- 17. In the event Consultant's fee schedule changes due to any increase of costs such as the granting of wage increases and/or other employee benefits to field or office employees or any taxes or fees imposed by local, state, or federal government on consultants' fees during the lifetime of this agreement, the new fee schedule shall apply to all subsequent work on time-and-materials contracts.
- 18. If payment for Consultant's services is to be made on behalf of Client by a third party lender, Client agrees that Consultant shall not be required to indemnify the third party lender, in the form of an endorsement or otherwise, as a condition to receiving payment for services. Client agrees to reimburse Consultant for all collection agency fees, legal fees, court costs, reasonable consultant staff costs and other expenses paid or incurred by Consultant in the event that collection efforts become necessary to enforce payment of any unpaid billings due to Consultant in connection with the services provided in this agreement.

LIMITATION OF LIABILITY

19. Notwithstanding any other provisions of this Agreement to the contrary, the aggregate liability of the Consultant under this Agreement, whether for breach of contract, tort, strict liability or any other legal theory, will not exceed the total amount of Consultant's compensation for performing services under this Agreement or \$50,000, whichever is greater, however this limitation of Consultant's liability does not apply to third-party claims, or to the Client's reasonable attorneys' fees and expert witnesses' fees and litigation expenses arising out of or related to such third-party claims for which Consultant is liable.

DISPUTE RESOLUTION

20. In an effort to resolve any conflicts or disputes that arise regarding performance under this agreement by either party, Client and Consultant agree that all such disputes shall be submitted to nonbinding mediation, using a mutually agreed upon mediation services experienced in the resolution of construction disputes. Unless the parties mutually agree otherwise, such mediation shall be a precondition to the initiation of any litigation. The parties further agree to include a similar mediation provision in their agreements with other independent contractors and consultants retained for the project and require them to similarly agree to these dispute resolution procedures. This provision shall not be interpreted to restrict the right of either party to file an action in a court of law, in the County of Fresno, State of California, having appropriate jurisdiction or to preclude or limit the Consultant's right to record, perfect or to enforce any applicable lien or Stop Notice rights.

CONSTRUCTION PROJECTS

- 21. If the scope of services contained in this agreement does not include construction phase services for this project, Client agrees that such construction phase services will be provided by Client or by others. Client assumes all responsibility for interpretation of the contract documents and for construction observation and supervision and waives any claim against Consultant that may in any way be connected thereto. In addition, Client agrees to indemnify and hold Consultant harmless from any loss, claim, or cost, including reasonable attorneys' fees and costs of defense, arising or resulting from the performance of such services by other persons or entities and from any and all claims arising from the modification, clarification, interpretation, adjustments or changes made to the contract documents to reflect changed field or other conditions, except for claims arising from the negligence or other wrongful acts of Consultant, its employees, its subconsultants, or any other person or entity for which Consultant is responsible.
- 22. Client agrees to include provisions in its contract with the construction contractor to the effect that in accordance with generally accepted construction practices, the construction contractor will be required to assume sole and complete responsibility for job site conditions during the course of construction of the project, including safety of all persons and property, and that this requirement shall apply continuously and not be limited to normal working hours. Neither the professional activities of Consultant nor the presence of Consultant or its employees or subconsultants at a construction site shall relieve the contractor and its subcontractors of their obligations, duties and responsibilities including, but not limited to, construction means, methods, sequence, techniques or procedures necessary for performing, superintending or coordinating all portions of the work of construction in accordance with the contract documents and applicable health or safety requirements of any regulatory agency or of state law.
- 23. Client agrees to require its contractor and subcontractors to review the plans, specifications and documents prepared by Consultant prior to the commencement of construction phase work. If the contractor and/or subcontractors believe there are deficiencies, conflicts, errors, omissions, code violations, or other deficiencies in the plans, specifications and documents prepared by Consultant, contractors shall notify Client so those deficiencies may be corrected or otherwise addressed by Consultant prior to the commencement of construction phase work.
- 24. If, during the construction phase of the project, Client discovers or becomes aware of changed field or other conditions which necessitate clarifications, modifications or other changes to the plans, specifications, estimates or other documents prepared by Consultant, Client agrees to notify Consultant and, at Client's option, retain Consultant to prepare the necessary changes or modifications before construction activities proceed. Further, Client agrees to require a provision in its construction contracts for the project which requires the contractor to promptly notify Client of any changed field or other conditions so that Client may in turn notify Consultant pursuant to the provisions of this paragraph.
- 25. If, due to the Consultant's error, omission or negligence, a required item or component of the Project is omitted from the Consultant's construction documents, the Consultant shall not be responsible for paying the cost required to add such item or component to the extent that such item or component would have been required and included in the original construction documents. The Consultant will not be responsible for any cost or expense that enhances the value of the Project.

SUSPENSION AND TERMINATION

- 26. If the Project or the Consultant's services are suspended by the Client for more than thirty (30) consecutive calendar days, the Consultant shall be compensated for all services performed and reimbursable expenses incurred prior to the receipt of notice of suspension. In addition, upon resumption of services, the Client shall compensate the Consultant for expenses incurred as a result of the suspension and resumption of its services, and the Consultant's schedule and fees for the remainder of the Project shall be equitably adjusted.
- 27. If the Consultant's services are suspended for more than ninety (90) days, consecutive or in the aggregate, the Consultant may terminate this Agreement upon giving not less than five (5) calendar days' written notice to the Client.

- 28. If the Client is in breach of the payment terms or otherwise is in material breach of this Agreement, the Consultant may suspend performance of services upon five (5) calendar days' notice to the Client. The Consultant shall have no liability to the Client, and the Client agrees to make no claim for any delay or damage as a result of such suspension caused by any breach of this Agreement by the Client. Upon receipt of payment in full of all outstanding sums due from the Client, or curing of such other breach that caused the Consultant to suspend services, the Consultant shall resume services, and there shall be an equitable adjustment to the remaining project schedule and fees as a result of the suspension.
- 29. Client acknowledges Consultant has the right to complete all services included in this agreement. In the event this agreement is terminated before the completion of all services, unless Consultant is responsible for such early termination, Client agrees to release Consultant from all liability for services not performed or completed by Consultant and from liability for any third-party reliance, use, interpretation or extrapolation of Consultant's work product. In the event all or any portion of the services by Consultant are suspended, abandoned, or otherwise terminated, Client shall pay Consultant all fees and charges for services provided prior to termination, not to exceed the contract limits specified herein, if any. Client acknowledges if the project services are suspended and restarted, there will be additional charges due to suspension of the services which shall be paid for by Client as extra services pursuant to Section 26. Client acknowledges if project services are terminated for the convenience of Client, Consultant is entitled to reasonable termination costs and expenses, to be paid by Client as extra services pursuant to Section 31.
- 30. The Client may terminate this Agreement for the Client's convenience and without cause upon giving the Consultant not less than seven (7) calendar days' written notice.
- 31. In the event of termination of this Agreement by either party, Consultant shall invoice Client for all outstanding services and expenses reasonably incurred by the Consultant in connection with the orderly termination of this Agreement, including but not limited to demobilization, reassignment of personnel, associated overhead costs and all other expenses directly resulting from the termination. The Client shall within thirty (30) calendar days of termination pay the Consultant for all services rendered and all reimbursable costs incurred by the Consultant up to the date of termination, in accordance with the payment provisions of this Agreement.

OTHER

- 32. This agreement shall be binding upon the heirs, executors, administrators, successors and assigns of Client and Consultant.
- 33. This agreement shall not be assigned by either Client or Consultant without the prior written consent of the other.
- 34. Consultant's or Client's waiver of any term, condition or covenant shall not constitute the waiver of any other term, condition or covenant. Consultant's or Client's waiver of any breach of this agreement shall not constitute the waiver of any other breach of the Agreement.
- 35. Client and Consultant agree that if any term or provision of this Agreement is determined to be illegal, in conflict with any law. void or otherwise unenforceable, and if the essential terms and provisions of this Agreement remain unaffected, then the validity of the remaining terms and provisions will not be affected and the offending provision will be given the fullest meaning and effect allowed by law.
- 36. This agreement shall be governed by and construed in accordance with the laws of the State of California.
- 37. Within the limits of the approved scope and fee, Consultant may engage the services of any subconsultants when, in the Consultant's sole opinion, it is appropriate to do so. Such subconsultants may include testing laboratories, geotechnical engineers and other specialized consulting services deemed necessary by the Consultant to carry out the scope of the Consultant's services.
- 38. Consultant shall be entitled to immediately, and without notice, suspend the performance of any and all of its obligations pursuant to this agreement if Client files a voluntary petition seeking relief under the United States Bankruptcy Code or if there is an involuntary bankruptcy petition filed against Client in the United States Bankruptcy Court, and that petition is not dismissed within fifteen (15) days of its filing. Any suspension of services made pursuant to the provisions of this paragraph shall continue until such time as this agreement has been fully and properly assumed in accordance with the applicable provisions of the United States Bankruptcy Court.
- 39. This agreement shall not be construed to alter, affect or waive any design professional's lien, mechanic's lien or stop notice right, which Consultant may have for the performance of services pursuant to this agreement. Client agrees to provide to Consultant the current name and address of

the record owner of the property upon which the project is to be located. Client also agrees to provide Consultant with the name and address of any and all lenders who may loan money on the project and who are entitled to receive a preliminary notice.

- 40. Consultant shall not be liable for damages resulting from the actions or inactions of governmental agencies including, but not limited to, permit processing, environmental impact reports, dedications, general plans and amendments thereto, zoning matters, annexations or consolidations, use or conditional use permits, project or plan approvals, and building permits. Client agrees that it is the responsibility of Client to maintain in good standing all governmental approvals or permits and to timely apply for any necessary extensions thereof.
- 41. Consultant and Client each agree to waive consequential damages for claims, disputes or other matters in question arising out of or relating to this Agreement. This mutual waiver is applicable, without limitation, to all consequential damages due to either party's termination in accordance with paragraphs 26 through 31, except for termination expenses provided for in said paragraph 31. Client further agrees that to the fullest extent permitted by law, Consultant shall not be liable to Client for any special, indirect or consequential damages whatsoever, whether caused by Consultant's negligence, errors, omissions, strict liability, breach of contract, breach of warranty or other cause or causes whatsoever, including but not limited to, loss of use of equipment or facility, and loss of profits or revenue.
- 42. This Agreement is the entire Agreement between the Client and the Consultant. It supersedes all prior communications, understandings and agreements, whether oral or written. Amendments to this Agreement must be in writing and signed by both the Client and the Consultant.

Dear Cristian Gonzalez:

Thank you for the opportunity to submit this proposal to provide civil engineering and land surveying services for the subject project. This proposal discusses our understanding of the project, recommends a scope of services together with associated fees, deliverables, and approximate schedules, sets forth our assumptions, and discusses other services that may be of interest as the project proceeds.

PROJECT UNDERSTANDING

We understand that the rehabilitation/reconstruction of the pavement and utility lines on several local streets is a new priority project for the City with the receipt of the congressional appropriation of \$5 million from Congressman Duarte via the Department of Housing and Urban Development's (HUD's) Fiscal Year 2024 Community Project Funding (CPF) program. The project will include reconstruction and/or rehabilitation of the asphalt pavement on all street segments listed below, as identified by the City Council at the April 4, 2024 regular City Council meeting, as well as reconstruction of some curb, gutter, sidewalk, driveway approaches, alley approaches, and replacement of existing striping. In addition, City Public Works staff have informed us that several water mains and service laterals have leaks or other issues that need to be addressed as a part of this project. The project will include the following segments of streets; water infrastructure improvement locations are noted below:

- 1. <u>Tule Street Seventh Street to Ninth Street</u>
 - a. Replacement of water main and service lines
- 2. <u>Rio Frio Street Fourth Street to Fifth Street</u>
- 3. Rio Frio Street Sixth Street to Seventh Street
 - a. Replacement of water service lines
- 4. <u>Quince Street Tenth Street to Belmont Avenue</u>
 - a. Replacement of water main and service lines
- 5. Lolita Street Divisadero Street to Tenth Street
 - a. Replacement of water service lines
- 6. Jennings Street Ninth Street to Quince Street
- 7. Fourth Street Rio Frio Street to State Route 180 (Oller Street)
- 8. Fourth Street –H Street to L Street
 - a. Replacement of water service lines
- 9. Kate Street I Street to the northern terminus
- 10. I Street Kate Street to Divisadero Street
 - a. Replacement of water main

The project may result in the removal of some street trees with roots that are destroying the pavement. The City will use CPF funds, water & sewer funds & local transportation funds for the project.

SCOPE OF SERVICES

Our proposed scope of work for this proposal will be in a single phase, described below.

PHASE PSE: PLANS, SPECIFICATIONS, AND COST OPINION

- Conduct Site investigation for the purposes of preparing construction documents.
 - a. Field Topographic Survey
 - b. Geotechnical Investigation
- Review findings and recommendations of Geotechnical Engineer's investigation and determine the appropriate method of construction.
- Design of street improvements, including pavement, striping, limited curb, gutter & sidewalk, drive approaches, alley approaches, and accessible curb ramps. Improvements to gutter drainage will be made where gutters are being replaced; however, there are drainage issues along these streets that are caused by conditions outside of the project limits. This project will not be able to completely address all drainage issues within the project limits.
- Prepare plans, specifications, and engineer's opinion of probable construction cost (PS&E). Street Improvement Plans will be double-window with a plan and profile view, at a scale of 1"=20' to allow for adequate illustration of detail; Water main replacement plans will be plan & profile at a scale of 1"=20'. Specifications will be in CSI format.
- We anticipate one preliminary submittal to the City for review when PS&E are approximately 50% complete, to discuss and agree on the approach to deal with any unique site issues. After review is complete, we will generate 100% final construction documents ready for use in bidding.
- We will coordinate with Caltrans, FCOG and HUD, preparing all necessary forms and coordinating information needs with City staff as required for the Request for Authorization to use the Federal CPF funds for construction. This includes environmental, utility and right of way clearances.
- We will administer the bidding process, responding to bidding contractor's requests for information, holding the public bid opening and reviewing submitted bids to prepare a recommendation of award of the construction contract by the City Council.

PROFESSIONAL FEES

Provost & Pritchard Consulting Group will perform the services in this Phase for the **fixed fee amount of \$525,000**. These services will be invoiced monthly, on a percent-complete basis. Reimbursable Expenses are included in the Fixed Fee amount stated.

SCHEDULE

Once we receive an executed copy of this Proposal together with the signed Consultant Services Agreement and are authorized to proceed, we can prepare the construction documents for the Request for Authorization and to be ready to advertise for bids in March 2025 to allow construction to commence in Summer 2025.

ASSUMPTIONS

- The new infrastructure will not be capacity-increasing and is therefore eligible for a Categorical Exemption under CEQA.
- No existing sewer, or storm drain facilities will need to be designed or replaced as a part of this project, other than adjustment of lids and manholes covers to match finished grade.
- Existing curb and gutter will be replaced, or new curb and gutter installed only where severely broken and unsuitable to be paved against, or where there are gaps in existing curb & gutter.
- Existing sidewalk will be replaced, or installed only where severely broken or where there are gaps in sidewalk.
- Construction limits for this project will not extend into the Caltrans State Route 33 (Derrick Avenue) nor State Route 180 (Oller Street) rights of way; therefore, coordination with Caltrans Encroachment Permits office is not anticipated.
- All improvements will occur within the existing street right-of-way and no acquisitions are required.
- If the scope of services requires Consultant to estimate quantities, areas and/or volumes for construction, such estimates are made on the basis of Consultant's experience and qualifications and represent Consultant's best judgment as a professional generally familiar with the industry and will be performed pursuant to generally accepted standards of professional practice in effect at the time of performance. However, such estimates are only estimates and shall not constitute representations, warranties or guarantees of the quantities of the subject of the estimate. If the scope of services requires Consultant's experience and qualifications and represents Consultant's best judgment as to be made on the basis of Consultant's experience and qualifications and represents Consultant's best judgment as to the probable construction costs. However, since Consultant has no control over costs or the price of labor, equipment or materials, or over the contractor's method of pricing, such opinions of probable construction costs, as compared to bid or actual costs.

ADDITIONAL SERVICES

The following services are not included in this proposal, however, these and others can be provided at additional cost, upon request.

- Street lighting, street tree, or landscape design.
- Construction testing or staking services.
- Construction administration, management, or observation services.
- Clarifications, adjustments, modifications and other changes due to field and other conditions that change by the time project construction occurs.
- All of the costs of preparation, examination and filing of Record of Survey or Corner Record.

TERMS AND CONDITIONS

If this proposal is acceptable, please sign the Consultant Services Agreement, and return a copy to our office. These documents will serve as our Notice to Proceed. This proposal is valid for 30 days from the date above.

ISSUE

Shall the City Council adopt Resolution No. 24-53, approving a General Plan Amendment, adopting the City of Mendota 6th Cycle Housing Element, and finding that such action is exempt from the California Environmental Quality Act ("CEQA") under Title 14 of the California Code of Regulations ("CEQA Guidelines") section 15061, subdivision (b)(3)?

BACKGROUND

Under California law, all cities and counties are required to adopt and maintain a general plan. (Government Code ["GC"], § 63500, et seq.) The general plan must contain eight mandatory elements (topical areas): land use, circulation, housing, conservation, open space, noise, safety, and environmental justice. The housing element is the only element that must be updated on a specified schedule. Each city or county is required to update its housing element every eight years. Each eight-year planning period is referred to as a "cycle." The current cycle is the 6th Cycle, which runs from 2023-2031. The County of Fresno, as well as all of the other San Joaquin Valley counties, are each making updates to their housing elements within the 2023-2031 cycle. (GC, § 65580-65589.11.) A housing element must identify and analyze the jurisdictions existing and projected housing needs to ensure adequate housing exists for all economic segments of the community.

The deadline for adoption of the City's 6th Cycle Housing Element ("Housing Element") was December 31, 2023, with a four-month grace period to April 30, 2024. While the City's housing element would be adopted subsequent to the end of the four-month grace period that the California Department of Housing and Community Development ("HCD") allows, there have been numerous additional changes and challenges during this housing element update cycle that have increased the amount of time needed to complete the 6th Cycle update. HCD, having initiated these changes, acknowledges the difficulty in meeting adoption by the April 30, 2024, grace period.

Prior to a jurisdiction adopting its housing element, it must submit draft documents to HCD for review. The jurisdiction revises the draft housing element based on HCD comments, provides a shortened public review period, then resubmits to HCD. Once HCD finds the document to be in substantial compliance with State law, the jurisdiction may adopt the housing element, after which HCD will certify it.

The City Council reviewed the Housing Element at its June 27, 2023, meeting. The Planning Commission then reviewed the Housing Element at its July 18, 2023, meeting. Following those reviews, the City initially submitted the Housing Element to HCD on September 29, 2023. Following receipt of informal HCD comments on November 15, 2023, and making the corresponding revisions, the City resubmitted to HCD on December 18, 2023. HCD provided formal comments on December 26, 2023, requesting additional revisions be made.

After making the second round of revisions, the City resubmitted the Housing Element to HCD on April 26, 2024. Correspondence with HCD on June 4, 2024, resulted in revisions to the Housing Element, which was resubmitted to HCD on June 21, 2024. In a letter dated June 24, 2024, HCD found that the Housing Element had been revised to meet the statutory requirements for compliance of State Housing Element Law (see Attachment 2).

Staff is presenting the Public Hearing Draft Housing Element to the Planning Commission for public comment on the document and to obtain a favorable recommendation to forward the document to the City Council for adoption. Following adoption, the Housing Element would be sent to HCD for certification.

Multi-Jurisdictional Housing Element

The Multi-Jurisdictional Housing Element is a regional housing document that effectively acts as the State-mandated housing element for all participating jurisdictions. Participating jurisdictions include the County of Fresno and the cities of Coalinga, Firebaugh, Fowler, Fresno, Huron, Kerman, Kingsburg, Mendota, Orange Cove, Parlier, Reedley, San Joaquin, Sanger, and Selma.

The Multi-Jurisdictional Housing Element is a single document, made up of two sections: 1) the main body, which describes demographics, housing needs, resources, and constraints at a regional level and includes goals and policies common to all participating jurisdictions; and 2) individual appendices, which contain details for each jurisdiction (i.e. sites inventory, governmental constraints, evaluation of existing Housing Element) and individual implementation programs.

The Draft 2023-2031 Multi-jurisdictional Housing Element describes housing needs in Mendota, identifies available sites for housing development, explains potential barriers to housing production, and contains the proposed policies to address the City's housing needs. For Mendota, Sections 1, 2, 3, 4, 5, 6, and Appendix 1I of the Multi-Jurisdictional Housing Element constitute the Draft Housing Element. These sections are what is being reviewed by the Planning Commission and are what will ultimately be presented to the City Council for its consideration. Due to the number of pages, it is impractical to include a copy of the Housing Element in the agenda Packet. The full text of the Housing Element can be found at: https://cityofmendota.com/city-of-mendota-housing-element/.

ANALYSIS

The Fresno Council of Governments adopted its final Regional Housing Needs Allocation ("RHNA") Plan in November of 2022. The plan included the final RHNA allocation for the City of 642 units. Of this 642 units, suballocations included 129 very low income units, 68 low income units, 97 moderate income units, and 348 above moderate income units. The 6th Cycle Housing Element outlines how the City's RHNA allocation can be met, as well as how the City can

affirmatively further fair housing within the City, improving housing choice and access for all residents of the City, regardless of demographic and socioeconomic status. As discussed above, the City Council and Planning Commission reviewed the Draft version of the 6th Cycle Housing Element at public meetings on June 27, 2023, and July 18, 2023, respectively. Subsequent to these meetings, and through working with HCD to become compliant with State Housing Element Law, revisions were made to the document. HCD's comment letters, dated December 26, 2023, and April 26, 2023, which resulted in the revisions to the document, have been included as attachments to this staff report (see Attachment 1 and 2).

The revisions were found to be satisfactory by HCD and resulted in a letter dated June 24, 2024, stating that the City's Housing Element will be in full compliance with State law once it has been adopted by the City Council (see Attachment 2).

The Planning Commission considered the Housing Element at its August 27, 2024, meeting and approved Resolution No. PC 24-10, forwarding a recommendation to the City Council to approve a General Plan Amendment, adopting the Housing Element.

ENVIRONMENTAL

The first step in complying with CEQA is to determine whether the activity in question constitutes a "project" as defined by CEQA, Public Resources Code section 21000, et seq. and the CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, Section 15000, et seq. A "project" consists of the whole of an action (i.e., not the individual pieces or components) that may have a direct or reasonably foreseeable indirect effect on the environment. The second step is to determine whether the project is subject to or exempt from the statute. This proposal qualifies as a project under CEQA because it involves "an activity directly undertaken by any public agency including but not limited to public works construction and related activities clearing or grading of land, improvements to existing public structures, enactment and amendment of zoning ordinances, and the adoption and the amendment of local General Plans or elements thereof pursuant to Government Code Sections 65100-65700" as described in CEQA Guidelines section 15378.

While updating the City's 6th Cycle Housing Element qualifies as a "project" under CEQA, the project involves the updating of goals, policies, and programs to meet the City's RHNA allocation and does not directly or indirectly approve any development. The project has no potential to result in a direct impact on the environment. As a result, because it can be seen with certainty that there is no potential for the project to impact the environment, the project is exempt from further environmental analysis pursuant to CEQA Guidelines section 15061, subdivision (b)(3). Therefore, the project is exempt under CEQA and a notice of exemption would be filed following project approval.

PUBLIC NOTICE

A Notice of Public Hearing was published in *The Business Journal* on September 6, 2024. It was also posted at City Hall and on the City's website.

FISCAL IMPACT

The drafting of the 6th Cycle Housing Element has been funded using general fund dollars in order to hire a consultant to perform the work. While the project has been funded through the general

fund, non-compliance with State Housing Element Law would result in penalties to the City that would significantly affect the City's ability to obtain grant funding in the future.

RECOMMENDATION

Staff recommends that the City Council adopt Resolution No. 24-53, approving a General Plan Amendment, adopting the City of Mendota 6th Cycle Housing Element, and finding that such action is exempt from the California Environmental Quality Act ("CEQA") under Title 14 of the California Code of Regulations ("CEQA Guidelines") section 15061, subdivision (b)(3).

RE: City of Mendota's 6th Cycle (2023-2031) Draft Housing Element

Thank you for submitting the City of Mendota's (City) draft housing element received for review on September 29, 2023, along with revisions received on December 18, 2023. The revisions were made available to the public for seven days prior to the California Department of Housing and Community Development (HCD) review. The review was facilitated by a conversation on November 15, 2023, with the City's housing element team. Pursuant to Government Code section 65585, HCD is reporting the results of its review.

The draft element, including revisions, addresses many statutory requirements; however, revisions will be necessary to substantially comply with State Housing Element Law (Gov. Code, § 65580 et seq). The enclosed Appendix describes the revisions needed to comply with State Housing Element Law.

Public participation in the development, adoption and implementation of the housing element is essential to effective housing planning. Throughout the housing element process, the City should continue to engage the community, including organizations that represent lower-income and special needs households, by making information regularly available and considering and incorporating comments where appropriate. Please be aware, any revisions to the element must be posted on the local government's website and to email a link to all individuals and organizations that have previously requested notices relating to the local government's housing element at least seven days before submitting to HCD.

For your information, pursuant to Assembly Bill 1398 (Chapter 358, Statutes of 2021), if a local government fails to adopt a compliant housing element within 120 days of the statutory deadline (December 31, 2023), then any rezoning to make prior identified sites available (e.g., Program 7 (Use of Sites in Previous Cycles)) or accommodate the regional housing needs allocation (RHNA) shall be completed no later than one year from the statutory deadline pursuant to Government Code sections 65583, subdivision Cristian Gonzalez, City Manager Page 2

(c)(1) and 65583.2, subdivision (c). Otherwise, the local government's housing element will no longer comply with State Housing Element Law, and HCD may revoke its finding of substantial compliance pursuant to Government Code section 65585, subdivision (i). Please be aware, if the City fails to adopt a compliant housing element within one year from the statutory deadline, the element cannot be found in substantial compliance until these rezones are completed.

Several federal, state, and regional funding programs consider housing element compliance as an eligibility or ranking criteria. For example, the CalTrans Senate Bill (SB) 1 Sustainable Communities grant, the Affordable Housing and Sustainable Communities program, and HCD's Permanent Local Housing Allocation consider housing element compliance and/or annual reporting requirements pursuant to Government Code section 65400. With a compliant housing element, the City will meet housing element requirements for these and other funding sources.

For your information, some general plan element updates are triggered by housing element adoption. HCD reminds the City to consider timing provisions and welcomes the opportunity to provide assistance. HCD appreciates the hard work and dedication demonstrated by the City and consultants throughout the housing element review and update. We are committed to assisting the City in addressing all statutory requirements of State Housing Element Law. APPENDIX CITY OF MENDOTA

The following changes are necessary to bring the City's housing element into compliance with Article 10.6 of the Government Code. Accompanying each recommended change, we cite the supporting section of the Government Code.

Housing element technical assistance information is available on HCD's website at <u>https://www.hcd.ca.gov/planning-and-community-development/hcd-memos</u>. Among other resources, the housing element section contains HCD's latest technical assistance tool, *Building Blocks for Effective Housing Elements (Building Blocks),* available at <u>https://www.hcd.ca.gov/planning-and-community-development/housing-elements/building-blocks</u> and includes the Government Code addressing State Housing Element Law and other resources.

A. Review and Revision

Review the previous element to evaluate the appropriateness, effectiveness, and progress in implementation, and reflect the results of this review in the revised element. (Gov. Code, § 65588 (a) and (b).)

The review requirement is one of the most important features of the element update. The review of past programs should analyze the City's accomplishments over the previous planning period. This information provides the basis for developing an effective housing program. While the element lists and describes programs, it should also describe the actual results in terms of housing outcomes, then evaluate the effectiveness of programs to better inform appropriate actions in the current element. For example, in some cases, the element explains the City participated in a County program or made a brochure or other information available but should also explain whether households were assisted. This analysis should be conducted for all programs, including programs intended to address special housing needs and programs should be revised, based on the outcomes of a complete analysis.

B. Housing Needs, Resources, and Constraints

 Affirmatively further[ing] fair housing in accordance with Chapter 15 (commencing with Section 8899.50) of Division 1 of Title 2...shall include an assessment of fair housing in the jurisdiction. (Gov. Code, § 65583, subd. (c)(10)(A).)

<u>Concentrated Areas of Poverty</u>: The element includes information relative to Racially and Ethnically Concentrated Areas of Poverty (R/ECAP) and areas of High Segregation and Poverty but should evaluate the characteristics of these areas, changes over time, comparisons to other neighborhoods in terms of equitable quality of life and consider other relevant factors, such as public participation, past policies, practices, and investments and demographic trends. Disproportionate Housing Needs, Including Displacement Risk: The element includes some general information on persons experiencing homelessness but should also evaluate that information. Specifically, the element should examine patterns of need or areas with higher concentrations of persons experiencing homelessness, including access to transportation and services. The element should utilize local data and knowledge such as service providers and code enforcement officials to assist this analysis.

<u>Contributing Factors to Fair Housing Issues</u>: Based on the outcomes of a complete analysis, the element should re-assess and prioritize the contributing factors to fair housing issues.

2. An inventory of land suitable and available for residential development, including vacant sites and sites having realistic and demonstrated potential for redevelopment during the planning period to meet the locality's housing need for a designated income level, and an analysis of the relationship of zoning and public facilities and services to these sites. (Gov. Code, § 65583, subd. (a)(3).)

<u>Realistic Capacity</u>: The element discusses assumptions for calculating residential realistic capacity (80 percent of maximum) and some mixed-use trends in nonresidential zones. However, the element should address the likelihood of 100 percent nonresidential uses in zones that allow 100 percent nonresidential uses and adjust residential capacity assumptions as appropriate, particularly for zones that don't allow 100 percent residential projects. For example, the element should discuss all recent development trends (residential and nonresidential), how often 100 percent nonresidential uses occur or is anticipated to occur, and how those trends are incorporated into the calculation of residential capacity.

<u>Annexation</u>: The element indicates several sites and projects that are undergoing an annexation process and appears to significantly rely on annexation to accommodate the regional housing needs allocation (RHNA), including for lower-income households. As a result, the element should include a specific analysis of the suitability and availability of these sites for development in the planning period, including the status, remaining steps to complete annexation and any barriers or constraints to the availability of these sites for development in the planning period. Based on the outcomes of a complete analysis, the element must modify Program 5 (Annexation for RHNA) to commit a schedule of actions that will facilitate annexation in the planning period, including, if necessary, meeting all byright requirements pursuant to Government Code section 65583.2, subdivisions (h) and (i).

3. An analysis of potential and actual governmental constraints upon the maintenance, improvement, or development of housing for all income levels, including the types of housing identified in paragraph (1) of subdivision (c), and for persons with disabilities as identified in the analysis pursuant to paragraph (7), including land use controls... ...and local processing and permit procedures... (Gov. Code, § 65583, subd. (a)(5).) Land Use Controls and Processing and Permit Procedures: The element utilizes the C-3 zone and planned development process for a significant portion of the RHNA and the element should include a specific analysis of the zone and the process to evaluate any potential constraints and add or modify programs, as appropriate. The evaluation should address how development standards are available, decision making authority, approval findings and any potential impacts on housing cost, timing, feasibility and approval certainty.

Additionally, the element includes a map of the Airport Land Use Compatibility (ALUC) Plan (p. 1I-43) and mentions that none of the constrained areas "located within the ALUC safety zones have been used in the site inventory." However, several sites appear to be contained within the ALUC Plan. The element should analyze the ALUC zones that cover portions of sites in the inventory and analyze how the safety zones impact development within the planning period, including development standards, siting, costs, approval certainty or any other relevant factors.

C. Housing Programs

 Identify actions that will be taken to make sites available during the planning period with appropriate zoning and development standards and with services and facilities to accommodate that portion of the city's or county's share of the regional housing need for each income level... Sites shall be identified as needed to facilitate and encourage the development of a variety of types of housing for all income levels, including... ...supportive housing...emergency shelters... (Gov. Code, § 65583, subd. (c)(1).)

As noted in Finding B2, the element does not include a complete site analysis; therefore, the adequacy of sites and zoning were not established. Based on the results of a complete sites inventory and analysis, the City may need to add or revise programs to address a shortfall of sites or zoning available to encourage a variety of housing types. In addition, the element should be revised, as follows:

- *Program 5 (Annexation for RHNA)*: The Program must commit a schedule of actions that will facilitate annexation in the planning period, including, if necessary, meeting all by-right requirements pursuant to Government Code section 65583.2, subdivisions (h) and (i).
- *Program 18 (Zoning Code Amendments)*: In addition to amending parking standards for emergency shelters, the Program should commit to establishing appropriate development standards in compliance with statutory requirements. In addition, the Program should clarify that zoning will be amended to permit permanent supportive housing without discretionary action.
- 2. The Housing Element shall contain programs which assist in the development of adequate housing to meet the needs of extremely low-, very low-, low- and moderate-income households. (Gov. Code, § 65583, subd. (c)(2).)

<u>Program 9 (Support Funding for Farmworker Housing)</u>: The Program should expand upon actions, such as adding additional proactive actions (e.g., identifying development opportunities at least twice in the planning period) to support the development of housing for farmworkers.

3. Address and, where appropriate and legally possible, remove governmental and nongovernmental constraints to the maintenance, improvement, and development of housing, including housing for all income levels and housing for persons with disabilities... (Gov. Code, § 65583, subd. (c)(3).)

As noted in Findings B3, the element requires a complete analysis of potential governmental constraints. Depending upon the results of that analysis, the City may need to revise or add programs and address and remove or mitigate any identified constraints.

4. Promote and affirmatively further fair housing opportunities and promote housing throughout the community or communities for all persons regardless of race, religion, sex, marital status, ancestry, national origin, color, familial status, or disability, and other characteristics. (Gov. Code, § 65583, subd. (c)(5).)

As noted in Finding B1, the element requires a complete affirmatively furthering fair housing (AFFH) analysis. Depending upon the results of that analysis, the City may need to revise or add programs. In addition, goals and actions must specifically respond to the analysis and the identified and prioritized contributing factors to fair housing issues and must be significant and meaningful enough to overcome identified patterns and trends. Actions must have specific commitment, metrics or numeric targets, geographic targeting, and milestones and must address, as appropriate, housing mobility enhancement, new housing choices and affordability in high opportunity areas, place-based strategies toward community revitalization, and displacement protection. For example, the element should expand place-based strategies toward community revitalization beyond implementing general plan policies. HCD will send sample programs under separate cover.

D. Public Participation

Local governments shall make a diligent effort to achieve public participation of all economic segments of the community in the development of the Housing Element, and the element shall describe this effort. (Gov. Code, § 65583, subd.(c)(9).)

While the element provides a general overview of the public participation process, the element must also provide a discussion on how comments from public outreach were considered and incorporated into the housing element. For example, the element could summarize the feedback received and describe the actions incorporated into the housing element resulting from the feedback. RE: City of Mendota's 6th Cycle (2023-2031) Revised Draft Housing Element

Thank you for submitting the City of Mendota's (City) revised draft housing element received for review on April 26, 2024, along with revisions received on June 21, 2024 and technical edits on June 24, 2024. The revisions were posted and made available to the public for seven days prior to review. Pursuant to Government Code, the California Department of Housing and Community Development (HCD) is reporting the results of its review. Our review was facilitated by a conversation on June 4, 2024, with the City's housing element team.

The revised draft element, including revisions and technical edits, meets the statutory requirements of State Housing Element Law, including requirements described in HCD's December 26, 2023 review. The housing element will substantially comply with State Housing Element Law (Gov. Code, § 65580 et seq) when it is adopted, submitted to and approved by HCD, in accordance with Government Code section 65585.

As a reminder, the City's 6th cycle housing element was due December 31, 2023. As of today, the City has not completed the housing element process for the 6th cycle. The City's 5th cycle housing element no longer satisfies statutory requirements. HCD encourages the City to revise the element as described above, adopt, and submit to HCD to regain housing element compliance.

For your information, pursuant to Assembly Bill 1398 (Chapter 358, Statutes of 2021), as the City did not adopt a compliant housing element within 120 days of the statutory deadline (December 31, 2023). Programs 5 (Annexation for Regional Housing Needs Allocation (RHNA)) and 7 (Use of Sites in Previous Cycles) to rezone sites identified in prior planning periods and accommodate the RHNA must be completed no later than one year from the statutory deadline. Otherwise, the local government's housing element will no longer comply with State Housing Element Law, and HCD may revoke its finding of substantial compliance pursuant to Government Code section 65585, subdivision (i). Please be aware, if the City does not adopt a compliant housing element

within one year from the statutory deadline, the element cannot be found in substantial compliance until all necessary rezones are completed pursuant to Government Code sections 65583, subdivision (c)(1)(A) and 65583.2, subdivision (c).

Public participation in the development, adoption and implementation of the housing element is essential to effective housing planning. Throughout the housing element process, the City must continue to engage the community, including organizations that represent lower-income and special needs households, by making information regularly available while considering and incorporating comments where appropriate. Please be aware, any revisions to the element must be posted on the local government's website and to email a link to all individuals and organizations that have previously requested notices relating to the local government's housing element at least seven days before submitting to HCD.

Several federal, state, and regional funding programs consider housing element compliance as an eligibility or ranking criteria. For example, the CalTrans Senate Bill (SB) 1 Sustainable Communities grant, the Affordable Housing and Sustainable Communities programs, and HCD's Permanent Local Housing Allocation consider housing element compliance and/or annual reporting requirements pursuant to Government Code section 65400. With a compliant housing element, the City will meet housing element requirements for these and other funding sources.

For your information, some general plan element updates are triggered by housing element adoption. HCD reminds the City to consider timing provisions and welcomes the opportunity to provide assistance. HCD appreciates the hard work and dedication the City's housing element team provided in preparation of the City's housing element and looks forward to receiving the City's adopted housing element. 


