STORMWATER PROJECT

DATE: OCTOBER 11, 2024

ISSUE

Shall the City Council adopt Resolution No. 24-55, authorizing the submission of a financial assistance application and entering into a Financial Assistance Agreement for the 2nd Street Stormwater Project?

BACKGROUND

The Council for Watershed Health, the City Engineer and staff at Provost & Pritchard Consulting Group have been performing Technical Assistance ("TA") services utilizing Proposition 1 Stormwater funding to design stormwater management infrastructure to mitigate the flooding that occurs at the intersection of 2nd Street and Naples Street and along 2nd Street from Marie Street to Bass Avenue. The TA work will produce concept level plans and an application package for the Environmental Protection Agency ("EPA") Overflow and Stormwater Grant Program ("OSG") to fund the construction of the project.

ANALYSIS

The project will include "grey" and "green" components to address the stormwater management objective and involves improvements to the "Triangle Park" at the intersection of Bass Avenue and 2nd Street.

In order to provide a complete OSG application package, the City of Mendota ("City") must provide the attached resolution.

FISCAL IMPACT

The application is being prepared with Proposition 1 TA funds, at no cost to the City. This will not impact the General Fund. There is approximately \$7 million earmarked for the City for the construction of this project under the OSG program.

RECOMMENDATION
